## **Position Summary**

Ability and knowledge from previous experience and/or schooling to maintain, repair, and service all types of heavy equipment (Dozers, Excavators, Off Road Trucks, water pumps, etc. in addition to DOT dump trucks, tractors, and trailers. Knowledge in engine overhauls is a plus. Must be able to supply your own tools and work both in the shop and out in the field to perform the work. All work is local with the Houston general area. Must have at least 4 years of technical school or on the job combined experience.

# **Position Responsibilities:**

- Diagnose and Perform routine maintenance and repairs as necessary on all types of Diesel equipment in compliance with the manufacturers' and company's schedules
- Analyzes mechanical and operational problems on assigned equipment and ability to schedule corrective action. Makes necessary corrections and running adjustments to maintain maximum production and quality.
- Repairs and maintains tractor trailer truck cabs and trailers, company automobiles, pick-up and delivery trucks.
- Inspects and maintains electrical systems and control.
- Uses hoist wrenches, gauges, drills or grinders, or other specialized auto mechanic tools and equipment.
- Maintains part usage records and orders repair parts from designated suppliers.
- Examines, tests, and measures product from assigned equipment for quality specifications, using gauges and instruments, and records data on appropriate forms. Checks product for visual defects.
- Makes preventive maintenance check and inspection of assigned equipment, report's findings to supervisor and takes appropriate action.
- Examines defects and analyzes spoilage causes and, where possible, takes corrective action. Analyzes and records cause of production delays on daily production report.
- Instructs and directs any maintenance trainees assigned.
- Perform Inspection and perform repairs on any area of the heavy equipment and trailers.
- Responsible for shop cleanliness, Company Truck safety and compliance
- Applies knowledge and works in accordance with DOT, Environmental Protection Agency (EPA), Interstate Authority, Occupational Safety and Health Administration (OSHA) and other rules and regulations
- Perform safety inspections of equipment and prepare safety documentation required
- Diagnose and repair mechanical and electrical problems according to manufacturers' recommendations and specifications.
- Maintain complete personal tool inventory necessary to perform functions.
- Inspects and tests equipment at prescribed intervals of time or usage or because of breakdown or malfunction. Immediately removes from service any potentially dangerous equipment.
- Disassembles, inspects, and replaces worn or broken parts. Grinds and fits parts as required to maintain or
  overhaul motors, transmissions, clutches, rear ends, steering devices, brakes and wheels, lifts, hoists, and
  hydraulic systems.
- Test drives repaired equipment before turning over to operators.
- Changes, charges and maintains battery fluid at prescribed level. Cleans battery connectors.
- Maintains records of vehicle maintenance and parts usage. Orders repair parts from stores department or designated outside suppliers.
- Perform undercarriage inspections, check bucket wear and cause of failure to pin, bushings to buckets.
- Must demonstrate and maintain an excellent record of punctuality and attendance.
- Perform other duties as directed by supervisor.

- Ability to understand and follow oral and written directions.
- Ability to read alpha and numeric; ability to use simple math.
- Must be able to work flexible schedule (including weekends, holidays as necessary)
- Have attention to detail
- Stay current on equipment and technologies that enhance productivity

- Demonstrated experience in general heavy truck repair for commercial fleet operations, including trailer repair, diesel engine system diagnostics and preventative maintenance for tractor mechanics
- Able to do heavy lifting, pulling (up to 50 pounds) or working in awkward positions or lying on back on auto mechanic's "creeper," working beneath truck.
- Ability to use hand tools and trades type tools.
